BYLAW NO. 1400

A bylaw to authorize closure and removal of the dedication as highway

WHEREAS, pursuant to Section 40 (1)(a) and (2)(b) of the Community Charter, Council may, by bylaw, close all or part of a highway and remove the dedication of a highway;

AND WHEREAS the Council of the District of Hope deems it necessary to close and cancel the dedication of a portion of highway as shown and described on the reference plan accompanying this bylaw, confirmed by Valley Surveys and completed on the 28th day of August 2017 (hereinafter referred to as the "Plan") a copy of which is attached hereto as Schedule "A"; land for closure off Raab Street, Fourth Avenue and Former Mills Street and the road right-of-way at the end of Fourth Avenue, including a segment of Fourth Avenue;

NOW THEREFORE the Council of the District of Hope, in open meeting assembled, enacts as follows:

1. This bylaw may be cited for all purposes as ***"Highway Closure and Removal of Highway Dedication along Raab Street, Fourth Avenue and Former Mills Street Bylaw No. 1400, 2017"***
2. That portion of the following described road:

DESCRIPTION	AREA
Plan of 3.413 acre portion of Lots 32, 38, 39 & 41, Block 2, Hope Suburban, Yale District	521 m ²

shown as parcel "A" and highlighted in green, on the Plan is hereby stopped up and closed to traffic.

3. That the dedication as highway of the portion of the following described road:

DESCRIPTION	AREA
Subdivision of Lots 38, 39, 40 & 41, Suburban Block 2 Townsite of Hope Yale Division of Yale District BC	3407 m ²

shown as parcel "B" and highlighted in orange, on the Plan be cancelled.

4. That prior to adoption of this bylaw, the Council shall cause public notice to be given by advertising once each week for two consecutive weeks in the newspaper published and circulating in the District of Hope.

5. That the Mayor and Corporate Officer are hereby authorized to execute the necessary conveyance and plan on behalf of the District of Hope, and generally do all things necessary to carry out the purpose of this bylaw.
6. This bylaw shall take effect upon adoption thereof.

Advertised in the Hope Standard Newspaper September 7, 2017, and September 14, 2017.

Read a third time this 20th day of September, 2017.

Received Ministry of Transportation & Infrastructure approval this 21st day of September, 2017.


