Note 1: You must disclose if your dog has been deemed vicious or dangerous in any municipality. A "vicious dog" means a dog that has attacked, bitten or caused injury to a person or has demonstrated a propensity, tendency or disposition to do so; has aggressively pursued or harassed a person or domestic animal; a dog with a known propensity to attack or injure a person without provocation; a dog owned or harboured primarily, or in part, for the purposes of dog fighting or a dog trained for dog fighting. A "potentially vicious dog" means has been impounded three (3) times within the previous calendar year; the owner has received a ticket for the dog running at large three (3) times within the previous calendar year; or the owner has received a total number of three (3) impounds and tickets within the previous calendar year. See Dog Responsibility Bylaw No. 1245.

Note 2: You must provide supporting documentation for spayed or neutered dogs or Guide Dogs.
