To gather the views of residents/businesses in a 50 metre radius from the subject property at 740A Fraser Avenue for the consideration of an application for a Non-Medical Cannabis Retail Store licence.




The newest dispensary proposed is definitely withing the 100 meter restrictions approved by the previous District of Hope council.
