

DISTRICT OF HOPE BYLAW NO. 1456, 2019

A bylaw to impose rates on all taxable land and improvements for the year 2019

Whereas Section 197 of the *Community Charter* requires that Council must adopt a bylaw to impose rates on all taxable land and improvements for the current year;

Now therefore, the Municipal Council of the District of Hope, in open meeting assembled, enacts as follows:

Title:

1. This bylaw may be cited for all purposes as the "District of Hope 2019 Annual Tax Rate Bylaw No. 1456, 2019".

Enactment:

- 2. The following rates are hereby imposed and levied for the year 2019:
 - (a) For all lawful GENERAL PURPOSES of the municipality on the value of land and improvements taxable for general municipal purposes, rates appearing in line A General Municipal of Schedule "A", attached hereto and forming part of this bylaw.
 - (b) For purposes of FRASER VALLEY REGIONAL DISTRICT services on the value of land and improvements taxable for Regional Hospital District purposes, rates appearing in line B Regional District Services of Schedule "A", attached hereto and forming part of this bylaw.
 - (c) For HOSPITAL PURPOSES on the value of land and improvements taxable for Regional Hospital District purposes, rates appearing in line C Regional Hospital of Schedule "A", attached hereto and forming part of this bylaw.
- 3. The minimum amount of taxation upon a parcel of real property shall be one dollar (\$1.00).
- 4. Penalties on unpaid current taxes shall be in accordance with the "Town of Hope Tax Penalty Bylaw No. 23/92".
